Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number
- Account Balances
- Credit History
- Checking Account Information
- Payment History
- Credit Scores

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Wilcox County State Bank chooses to share; and whether you can limit this sharing.

Definitions

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial or nonfinancial companies.</p> <p><i>Wilcox County State Bank does business as Irwin County</i></p> <ul style="list-style-type: none"> ■ <i>State Bank in Ocilla, GA and Milan State Bank in Milan, GA, but Wilcox County State Bank does not have any affiliates</i>
<p>Nonaffiliates</p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ <i>Wilcox County State Bank does not share with any non-affiliates.</i>
<p>Joint marketing</p>	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ■ <i>Wilcox County State Bank shares with EconoCheck, Inc., and ServisFirst Bank so they can market to you.</i>
